## SUMMARY ANNUAL REPORT FOR DSRA BENEFIT TRUST PLAN

This is a summary of the annual report of the DSRA Benefit Trust Plan, a health, life insurance, dental and vision plan (Employer Identification Number 26-4594868, Plan Number 501), for the plan year 01/01/2016 through 12/31/2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Insurance Information**

The plan has insurance contracts with Metropolitan Life Insurance Company, Hartford Life & Accident, Reliance Standard Life Insurance Company, Blue Cross Blue Shield of Michigan and Express Scripts Insurance Company to pay certain life insurance, AD&D, Medicare supplement, health, dental, vision, and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2016 were \$21,565,401.

Because certain contracts are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2016, the premiums paid under such "experience-rated" contracts were \$17,873,687 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$14,421,555.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$1,555,477 as of the end of plan year, compared to \$1,760,332 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$204,855. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$22,224,298 including employee contributions of \$21,981,433, earnings from investments of \$61,558 and other income of \$181,307. Plan expenses were \$22,429,153. These expenses included \$1,076,952 in administrative expenses and \$21,352,201 in benefits paid to participants and beneficiaries.
