SUMMARY ANNUAL REPORT

FOR DELPHI SALARIED RETIREES ASSOCIATION BENEFIT TRUST

This is a summary of the annual report for the DELPHI SALARIED RETIRES ASSOCIATION BENEFIT TRUST, EIN 26-4594868, Plan #501, for the plan year of January 1, 2011 through December 31, 2011. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

DELPHI SALARIED RETIREES ASSOCIATION BENEFIT TRUST has committed itself to pay hardship payment claims incurred under the terms of this plan.

Insurance Information

The plan has contracts with BLUE CROSS BLUE SHIELD OF MICHIGAN, EXPRESS SCRIPTS INSURANCE COMPANY, HARTFORD LIFE AND ACCIDENT and NATIONAL GUARDIAN LIFE INSURANCE COMPANY to pay health, dental, prescription drug, supplemental Medicare, life insurance and vision claims incurred under the terms of this plan. The total premiums paid for the plan year ending December 31, 2011 were \$49,624,414.

Because there is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2011, the premiums paid under the "experience-rated" contract was \$47,565,306 and the total of all benefit claims paid under this experience-rated contract during the plan year was \$39,517,469.

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$55,490,493. These expenses included \$44,582 in hardship payments, \$53,611,885 in premium paid to insurance carriers for providing plan benefits and \$1,834,026 in administrative expenses.

The value of plan assets, after subtracting liabilities of the plan, was \$16,490,028 as of December 31, 2011, compared to \$7,777,184 as of December 31, 2010. During the plan year, the plan experienced an increase in its net assets of \$8,712,844. The plan had total income of \$64,203,337, including retiree contributions of \$19,968,172, Health Coverage Tax Credit contributions of \$43,979,808, interest income of \$574, dividend income of \$349,387, realized gain of \$5,410 and loss from investments of (\$100,014).
